- hereby specifies that the non-governmental schools specified in column (2) charging the fee lower than the fee specified in column (3) of the Table shown below, shall be exempted from the determination of fee, provided they obtain exemption certificate from Fee Regulatory Committee.
- directs that the schools which are charging the fee more than the fees specified in column (3) of the said Table shall require to submit the proposal for approval and fixation of fee in accordance with provisions of the said Act.
