**Terms and Conditions:-**

1. The headquarter of the Fee Revision Committee shall be at Guwahati or at such other place, as may be decided by the Chairperson of the Committee.
2. A person or any institution aggrieved by the order of the Fee Regulatory Committee made under Section 11 of the Assam Non-Government Educational Institutions (Regulation of Fees) Act, 2018 may file revision application before the Fee Revision Committee within a period of twenty one days from the date of receipt of such order.
3. If the Fee Revision Committee is satisfied that such institution was prevented for filing a revision application within prescribed time-limit for sufficient cause, it may condone the delay and shall allow the revision application but not later than three months.
